# Publication of transparency notification(s) received by KBC Group NV

(art. 14, 1st section of the Act of 2 May 2007 concerning the disclosure of significant participations)

#### Summary of the notification(s)

KBC Group NV has received a transparency notification dd. 5 October 2018 and dd. 8 October 2018, which – as a result – state that BlackRock Inc. has crossed the reporting threshold of 5% (total voting rights) first upwards and then downwards.

#### Content of the notification(s)

The notification(s) contain(s) following information:

- Reason for the notification(s): acquisition or disposal of voting securities or voting rights
- Notification(s) by: BlackRock Inc.
