KBC Bank NV (Belgium) and the Czech start-up Digital & Legal s.r.o. ('Green0meter') enter into joint venture to advise Czech SMEs on their journey to becoming more sustainable.

KBC Bank NV entered into a joint venture with Digital & Legal s.r.o.. This company is the legal entity behind the young Czech technological platform Green0meter. KBC will acquire a 50% stake in Digital & Legal, with the option to acquire the remaining shares at a later stage. Both parties agreed not to disclose financial details of the deal, which in any case is immaterial for KBC.

Green0meter focuses on sustainability services and providing CO₂ footprint calculation and ESG services to Czech SMEs. As a leader in ESG, ČSOB Group wants to enable its Czech SME clients to meet the changing expectations in society as well as the changing EU ESG requirements better and more efficiently.

Aleš Blažek, CEO of KBC's Czech Business Unit, comments on the agreement: *'The partnership between KBC and Green0meter will ensure that ČSOB's business clients are provided with fully individualised, professional sustainability advice tailored to their specific business processes and needs, in combination with suitable financing options. This will ensure that the transition to a more sustainable business model develops organically from within the business itself, with KBC, ČSOB and the Green0meter platform acting as catalyst and facilitator in the transition to more sustainable business operations. The new consultancy is implemented in the online banking platform which ensures the maximum added value of this service for the clients. I'm proud that Digital & Legal and ČSOB have a shared history, since it's one of the start-ups that successfully graduated from the Start it @ČSOB business accelerator programme. Digital & Legal's Green0meter platform clearly is a complementary asset within the KBC and ČSOB ESG proposition, offering strategic and business benefits to our clients, employees, society and other stakeholders.'*
