KBC Group announces the launch of a capped cash tender offer for one of its outstanding AT1 securities and the intention to concurrently issue new AT1 securities.

Today, KBC Group NV ("KBC Group") announces the launch of a capped tender offer for its outstanding €1,000,000,000 Undated Deeply Subordinated Additional Tier 1 Fixed Rate Resettable Callable Securities (ISIN: BE0002592708) (the "Securities") for cash. Holders of the Securities can find more information in the launch announcement which is available through the following [link](#) (the "Launch Announcement").

Concurrently with the tender offer, KBC Group intends to issue new Undated Deeply Subordinated Additional Tier 1 Fixed Rate Resettable Callable Securities (the "New Securities"), subject to market conditions.

The maximum acceptance amount of the tender offer is expected to be equal to the aggregate principal amount of the New Securities.

Johan Thijs, KBC Group CEO commented on the announcement as follows: *"KBC Group intends to take advantage of favourable market conditions to proactively manage its AT1 securities and lengthen its redemption profile."*

KBC is a strongly positioned and well-capitalised financial institution in Europe. Its fully loaded common equity tier-1 ratio under the current Basel III framework stood at 15.1% at the end of the second quarter of 2024. KBC's core strategy remains focused on providing bank-insurance products and services to retail, SME and mid-cap clients in its core markets of Belgium, the Czech Republic, Slovakia, Hungary and Bulgaria.
